2. Revised ABE English Intermediate Outcomes

- Discussion regarding revisions to our ABE English learning outcomes to match the equivalent outcomes in BC's Grades 10-12 English curricula—and also discussed how to ensure that our outcomes meet the expectations for learning outcomes at our institutions (e.g. measurable learning outcomes)
- Discussed including required and recommended learning outcomes, need for greater clarity in our outcomes (e.g. discussion about whether to require specific length and type of assignment, like in the English 12 course with the 1500-word research essay), and need to include First Peoples articulation committee recommendations.
- Outcomes are still a work in progress to be continued.

3. Revising Advanced English Outcomes

Learning Outcomes Sub-committee – Cari-Ann, Anne, Margaret, and Alice will begin revision this
year with an eye to keeping a clear progression from Intermediate to Advanced to Provincial, and
they will be in touch with the First Peoples ABE Working Committee regarding their
recommendations.
