## 8:50 - School Reports (reports can be found on the BCCAT Moodle site)

Roy Rea – School Report from UNBC

- John K. question on chemistry course requirements.
- Numerous faculty retiring with some new hiring. Great new talent with lots of publications.
- Community outreaching ramping back up following COVID.

### John K. - School report from TRU

- Recently went through program review.
- Gave history of how program originated. Strong focus on what was needed in industry.
- Accreditations BCIA; Some changes to program required for CAB upper level evolution courses.
- Two new faculty Dr. Mike Flannigan and Dr. Jillian Harvey.
- Looking to hire new Indigenous scholar into a full time faculty position.
- John spoke to the difficulties TRU has faced recently with improper conduct of top administrators.

### Steve Finn - School report from BCIT

- Steve spoke to question on micro-credentials. Non-credit micro-credential or non-transferable credits. Strong enrolment. Mostly a PD-type of opportunity.

#### Colleen MacLean - NIC school report

- John K. confirmed courses are credit-based.

Tom Willms - NVIT school report

#### M. Flannagan – Selkirk school report

- John noted that the majority of transfer students to TRU come from Selkirk.
- Tom noted that Selkirk and NVIT have teamed up on grasslands field trips in the past and it would be great to continue that.

Stacy – VIU school report

- John K comment on Michel Vallee's passing and all of the work he did at VIU.
- Andres comment on preparing students for transfer to Universities numerous students move on to Uni.
- Andres commented on TAC biggest learning was becoming more acquainted with their own institution, being connected with registration.
- Casey commented on students that embrace the standards/competencies in accreditation really appreciate it. Many just see as hurdles.

## Dominik Roeser – UBC school report

- Strong undergraduate program enrolment but dropping in FRM and forestry-related programs. Increasing numbers and interest in conservation and urban forestry. Lots of concern about old-growth negatively affecting forestry enrolment.
- Lots of demand from industry to get more students through the program. Many students having to come back to school to take required courses for registration with ABCFP.
- Still working on Indigenous Forest Land Stewardship program in Okanagan.
- Lots of interest in micro-credentials ("micro-certificates") mostly at the master's level.
- New Dean Rob Kozak
- Hired two Indigenous scholars.
- Forest Operations program students can take an extra year and become RPF and P.Eng.
- Noted overall increase in mental health problems in students (and faculty).

## Anna Tikina (BCCAT) Report

- Update from BCCAT. Noted upcoming Joint Annual Meeting will be hybrid online/in-person.
- BC Transfer Guide update and technology update.
- Many new publications available (e.g micro-credentials, impacts of COVID-19 on students, etc.)
- Question on what happens to transfers received/approved by receiving institutions they are entered into the BCCAT system, sometimes with an expiry for reassessment.
- Question regarding numbering system of courses in BCCAT Anna noted that it's only a minor change, not a content change.

## **ABCFP Report – Casey Macauley**

- Overview of registrant stats number of RPFs, RFTs, and diversity within the profession.
- Major uptick in registration starting in 2018 with increases in lumber prices, slowing (somewhat) with decreases in AAC.
- 50/50 split between FIT and ASFIT applicants for RPF. 76% of applicants for RFT are from accredited programs.
- Question from Colleen: Do students from non-accredited programs have to be assessed individually? Casey noted that the assessors end up knowing the programs well but each applicant is different. ASFITs are assessed as a national program. ABCFP wants to get to a userpay system for reviews.

- Gave summary of number of trainees by institute and program.
- Broad overview of National Technology Standard contemplating how these are grouped currently being reviewed/refined nationally.
- New standards will be sent to TAC and CFAB for implementation in accreditation reviews.
- Question to group: do we want to pull accreditation from TAC and pushed to CFAB?
- Indigenous Pathways in Natural Resources trying to increase accessibility, particularly in more remote locations.
- Spoke to the Professional Governance Act 22 months into its adoption and through first round on audits. Lots of work to determine which practices fall under which professional designations.
- ABCFP is partnering with UBC to create a bank of question for ASFIT registrants. Individual exams would be generated for applicants that appeal their evaluation re. knowledge/competency gaps.
- Looking to create online course that can be taken by applicants that need to fill education gaps can be take asynchronously for applicants that are working.
- Next year is the 75<sup>th</sup> anniversary of the ABCFP conference will be in PG.

#### Lunch Break - 12:10

### First Nations Forestry Council (FNFC) - Karen Sorensen - workforce initiatives and programs

- DRIPA-based actions
- Spoke to "Theme 3" Ending Indigenous-specific racism and discrimination
- Placing students or entering students in groups so they have support. FNFC provides care for students following up with schools to ensure students are supported.
- Theme 4 Social, cultural and economic well-being.
- Workforce Strategy developed out of the FNFC Forest Strategy.
- Call to action of filling 2000 forestry jobs by First Nations people by 2031
- Forestry Connect initiative implements the Workforce Strategy.
  - Connecting job seekers with employment opportunities.
- Indigenous Forestry Scholarship Program includes education costs and provides paid summer internships in the forest sector.
- There is a waiting list for the scholarship program. More demands than FNFC has funding for.
- Indigenous mentoring has to be two-way learning.
- Questions about how people can join focus groups come to the conference or reach out to Karen to be added to emailing list.
- Location for career fair to be determined.
- Questions related to Indigenous self-declaration. Who does the funding apply to.
- NVIT offers early-entrance scholarship to Indigenous high-school grads across BC (free tuition for one year). Could this scholarship be adopted by other institutions as well.
- A lot of government funding is attached to Indigenous initiatives resulting in disconnection between education, industry, etc. FNFC is trying to bring these things together. Making connections.
- Casey noted that we need to get all parties in the same room and talking, making connections and bringing things together.
- Need make more certifications for education already completed or training received on site.
- Mentorship framework is still being worked on and can being distributed when ready.

According to labour market data a lot of jobs are in machine operations and that's where there
are challenges in finding opportunities (small companies can't afford a full sponsorship or lost
machine time).

## Andrea Erwin – CNC School Report

- Accreditation with TAC complete, plus two annual update reports.
- Research Forest Society looking for the board to fund a seat from the FNFC for a student.
  - Awesome for support for the program. Brings funding of about \$30K
  - o Summer student employment opportunities.
  - Used for the majority student capstone projects. Faculty get six hours per week release time for the research forest.
- Study abroad program has been on hold due to COVID. Should be getting started again soon.
- Looking to fill an Instructor position in Fire course.
- Lots of creation of online content from hybrid learning.
- John K. asked where the classroom cap comes from (set at 22). Set in Collective Agreement.

## **Open Discussion**

- M. Flannagan asked what other programs are doing for applied research.
- Andrea noted that students at CNC are assigned a project.
- Stacy noted that VIU students can pick their own research project.
- Tom discussed some concerns with doing "research" at the technology level.
- Casey noted that we need to get a better economy of scale with accreditation processes.
- Colleen notes NIC schedules the applied research course over the entire second year.
- Everyone confirmed that there is a presentation component to student research projects.
- NIC has students complete group research projects.

## Shona Lawson - College of Applied Biologists Report

- Name change to College of Applied "Biologists" (from "Biology")
- CAB has no national body Just CAB and ASPB
- CAB has developed multiple new streams (RPBio, RBTech, ABT, Applied Biologist limited license).
- Lots of educational diversity, especially in less-rigorous categories. Example of applicants with graduate degrees preferring technician category vs. professional category due to responsibilities.
- Described College's Accreditation process.
- Described application and review process.
- Discussion around Biologist's right to practice coming down the pike (September 2022). Lots of applications coming in as people scramble to become designated.
- Casey described laddering effect from one level of education to the next.
- Comments on building confidence in smaller certificate types of programs.
- NIC articulated their weekly modules building on knowledge each week with applied workplace learning.

- Lots of capacity building needs in communities. Pressure to have quick certifications to get people working.
