# **MINUTES**

### 1. WELCOME & OPENING REMARKS – Rob Fleming & Jim Hamilton (Co-Chairs)

We acknowledge that the BCCAT office is situated on the unceded territory of the Coast Salish peoples, including the territories of the  $x^w$ mə $\vartheta$ kwəýəm (Musqueam), Skwxwú7mesh (Squamish), Stó:lō and Səlílwəta?/Selilwitulh (Tsleil-Waututh) Nations.

#### 2. PROPOSED AGENDA

The agenda was approved as presented.

## 3. MINUTES FROM PREVIOUS MEETING (March 13, 2023)

The minutes of the March 2023 meeting were approved as presented.

#### 4. COUNCIL BUSINESS

### 4.1. Provincial Issues and Developments

#### 4.1.1. Ministry Update

Morgan Beach (Director, Strategic Planning & Business Solutions, Ministry of Post-Secondary Education & Future Skills was introduced to members. Ben Ferrel provided a brief update regarding the implementation of the StrongerBC initiative. Ben noted that his branch is now responsible for WorkBC, which also works with EPBC, BCCAT, BCcampus and Digital Services.

### 4.1.2. Indigenous Education Update

Dianne Biin spoke briefly regarding recent discussions at the Indigenous Articulation Committee meeting. Discussions focused particularly on the question of how to creating pathways for Indigenous students. For example, how to use language credits for other types of educational pathways (offering more than general credit)?

### 4.2. Executive Director Report

#### 4.2.1. Key Activities & Developments

Rob Fleming updated members on recent activities and developments. A few key points are outlined below.

#### Ministry/Government

- Future Ready Announcement and Plan (launched at BCIT in May)
- TCS Pathways, as part of Digital Services Strategy
- Participation on the Digital Learning Strategy Advisory Committee
- Continued involvement with the Learning Continuity Working Group (focused on International Education Strategy Transitions)
- The nominations process for Council member appointments (and re-appointments) is underway.

#### BC Transfer System Consultation

- BC Transfer System Membership: Policy development in relation to IAHLA institutions to follow a
  pathways meeting in the fall and DQAB meeting looking at Associate Degrees, as further consultation is
  required.
- The Indigenous Articulation Committee plan to schedule regular meetings to discuss key issues (membership, articulation, pathways, etc.)
- May/June are traditionally "Articulation Season" with BCCAT staff members attending many committee meetings across the province. (See item 7.2 for more information.)

- Discussion with BCIT is underway regarding assignment and licensing of the TCS.
- NDA and discovery proposal are being developed for TCS feasibility discussions with OnCAT.

#### Inter-provincial / International Collaboration

- Aurora College has expressed an interest in participating in the transfer system. Meetings were held in April and May to discuss.)
- PCCAT's Learning Day was held on June 20, 2023. Rob Fleming participated in an inter-provincial panel.
- Manitoba Credit Transfer Articulation Forum held in May.
- Continued development and discussion with Campus Manitoba and OnCAT regarding a TCS partnership (e.g. consolidating intellectual property, licensing).

#### 4.2.2. Staff Report

The staff report was briefly reviewed, and there were no questions.

#### 4.2.3. Project & Activities Update

The Project & Activities chart was provided to update members on the status of key projects and activities in this year's work plan.

#### 4.2.4. Membership Applications and Policy

Currently, one new membership application was received from Western Community College (WCC) and will be reviewed by the TAC with an anticipated recommendation coming forward for Council's consideration at the fall 2023 meeting. (letter was provided for information.)

Based on discussion with other interested institutions, we anticipate two other applications to come forward within the next year. To prepare for adjudication of these applications, Council members were asked to review the criteria as set forward in the policy to help inform discussions at the next meeting.

#### 4.2.5. BC Transfer Guide System Principles and Guidelines Review

The <u>Principles & Guidelines for Transfer</u> sets out the operational principles and guiding values of the BC Transfer System. It was last reviewed in 2010. At the May 2023 meeting, the TAC passed a motion to recommend that Council form a subcommittee to review this document, and forward recommendations for revisions to the Council. The following motion was forward.

**MOTION:** To form a subcommittee of Council to review and update the Principles and Guidelines for Transfer.

## 4.3. 2022-23 & 2023-24 Budgets

#### 4.3.1. 2022-23 Final FYE Balances

Members reviewed the final FYE balances for 2022-23. Rob Fleming noted that a number of projects and initiatives (including some technology-related) had been accelerated in order to close them off by year end.

#### 4.3.2. 2023-24 Budget Update

Rob Fleming referred members to correspondence from the Ministry confirming BCCAT budget allocation for 2023-24. The base funding was in line with what was requested, to support BCCAT core operations in meeting its mandate. In addition to this allocation, additional funds (\$450,000, as special project funding) were approved for special projects (particularly technology-related projects) and staff support.

#### 4.4.2022-23 Annual Review

Valerie Yorkston presented the 2022-23 Annual Review, Sustaining Transfer: Growing an adaptive eco-system that mobilizes student journeys. This report functions as a component of BCCAT's accountability to the Ministry, and to provide an overview for post-secondary partners and the wider public. This year, the report looks at key collaboration and developments as BCCAT has continued its work with post-secondary partners to facilitate and advance learner access and mobility.

**MOTION:** To accept the FYE 2022-23 Annual Review, Sustainable Transfer: Growing an adaptive eco-system that mobilizes student journeys.

## 7. TRANSFER & ARTICULATION

### 7.1. Transfer & Articulation Committee (TAC) (Last Meeting: May 26, 2023)

The minutes of this meeting will be made available at the next Council meeting. Mike Winsemann noted Sam Saini is the new chair of the Committee. Meanwhile, Margaret Heldman is stepping down from the committee after contributing as a member for the past 10 years.

Key discussions included the proposed review of the Principles & Guidelines for Transfer and applications (and others expected shortly) for membership in the BC Transfer System.

#### 7.2. Articulation Committees

Mike noted that the TAC passed a motion to delist the Electronic Technicians committee. Meanwhile, the Electronic Engineering one is under review. BCCAT staff attended 35 committee meetings through May & June ("Articulation Season"). Travel appears to be less of a barrier this year, but the high cost of hotels in Vancouver remains a concern.

Hybrid formats for articulation committee meetings still pose a challenge; it is clear there is a need to make the online experience more accessible and integrated. Finally, key themes raised in discussion included:

- Post-pandemic effects on student wellness
- Al and ChatGPT
- New TCS technologies (e.g. transfer widget reciprocity)

## 7.3. TAC Projects

#### 7.3.1. BC Transfer Guide Course Inclusion Policy (Proposal)

As part of the TAC workplan, an ad hoc working group was formed in 2022 to assist in the development of a course inclusion policy for the BC Transfer Guide. Supported by BCCAT staff, the working group reviewed current practices, consulted with the BC Transfer System community, and developed recommendations for defining what courses should be published in the BC Transfer Guide. Based on the feedback received, the general consensus was that the current practices for course inclusion were sufficient, and that the current practice should be formalized as a written document.

The working group formalized these practices as a series of guidelines. These were reviewed by the TAC which then approved a motion to "endorse the Course Definition Guidelines and recommendations and direct staff to develop a Course Definition policy for review by the TAC in January 2023. At that meeting, the draft policy was presented to the TAC, and a motion "to recommend to Council to approve the BC Transfer Guide (BCTS) Course Inclusion Policy" was passed unanimously.

Members were referred to the draft policy, and the following motion was forwarded:

**MOTION:** To approve the BC Transfer Guide Course Inclusion Policy.

### 8. TECHNOLOGIES/WEBSITES

## 8.1. Transfer Credit System (TCS) Update

#### 8.1.1. TCS Developments

Mike reported on developments regarding sharing TCS technologies with OnCAT, noting that BCCAT is not a vendor, so not in a position to submit formal proposals. Instead, a potential partnership is being explored, and a gap analysis is underway. If this partnership proceeds, this could be a potential model for sharing technologies with other jurisdictions.

#### 8.1.2. TCS Suite

Mike noted that there have been no significant new developments regarding the TCS Suite since the last Council meeting, but that SFU is considering participating in the process.

#### 8.1.3. TCS Pathways

On behalf of Jennifer Kook, Mike provided a brief update, noting to modules:

- program pathways builder (pilot)
- construction of a robust pathways tool.

It is expected that a mockup of the pilot will be ready in the summer months.

**ACTION:** Jennifer Kook will provide another update that the October Council meeting.

### 8.2. BCCAT Websites Update

The BCCAT website has undergone a major refresh and will be launched today. Anabella Chun took on the bulk of this work, focused on improving access to BCCAT publications and policies, refresh the design, and make the site easier overall for users to navigate. ### 9.1. "Transfer To" Video Series

Val Yorkston played an example of a video from this new video series featuring pathways and transfer opportunities at BC's post-secondary institutions. When this series was launched, a number of other institutions expressed an interest in participating in the series, so work is proceeding with those, and they should be made available by the fall/winter.
