## 2018 BCCAT TRANSFER AWARDS

BCCAT is now accepting nominations for the *2018 BCCAT Transfer Awards* from colleagues working at a BC post-secondary institution or system agency operating within the BC Transfer System (see [bccat.ca/system/membership/](http://bccat.ca/system/membership/)).

### OVERVIEW

The *BCCAT Transfer Awards* are conferred in recognition of individuals or groups who have demonstrated exemplary leadership in the BC post-secondary system by engaging in activities that have made a significant and valuable contribution to the transfer community. The awards are presented based on evidence of activities demonstrating exceptional commitment to improving transfer and articulation for BC post-secondary students. There are four awards categories, as outlined below.

### AWARD CATEGORIES

*NOTE: For award categories 1-3, at least one award will be granted each year if suitable nominations are submitted. Depending on the number and quality of nominations, it is possible that additional awards may be granted in the same category. The Lifetime Achievement Award will be awarded only when exemplary nominations are received.*

#### 1. LEADERSHIP AWARD

This award recognizes an individual or group for demonstrating exemplary leadership that has had a significant and positive impact on advancing the theory and practice of transfer and articulation within the BC Transfer System.

- *Eligibility: Individual(s) employed at a BC Transfer System institution or BC post-secondary agency in support of higher education in the province of BC, for a minimum of 5 years.*

#### 2. TRANSFER & ARTICULATION COMMUNITY LEADERSHIP AWARD

This award recognizes an individual or group for their contributions to the BC Transfer System in their role(s) as community leaders and active volunteers in professional service to the broader articulation community. NOTE: A prime example would be an individual serving in an articulation committee, or the committee itself.

## INFORMATION SHEET

- *Eligibility: Individual(s) employed at a BC Transfer System institution or BC post-secondary agency in support of higher education in the province of BC.*

### 3. RISING STAR AWARD

This award recognizes an individual or group of individuals who, while early in their career, demonstrates exceptional leadership and accomplishment in the area of transfer and articulation within the BC Transfer System.

- *Eligibility: Individual(s) employed at one or more BC Transfer System institutions or system agencies in support of higher education in the province of BC for the past five years or less.*

### 4. FRANKLIN GELIN LIFETIME ACHIEVEMENT AWARD (Occasional)

This award recognizes an individual whose long-term contributions and far-reaching impacts have become apparent over a career of commitment to advancing transfer and articulation in the BC post-secondary system. *NOTE: This award will be presented on an occasional basis, and only when outstanding nominations are received.*

- *Eligibility: An individual currently or previously employed at one or more BC Transfer System institutions and/or system agencies in support of higher education in the province of BC for eight or more years.*

## NOMINATION PROCESS

Nominators are responsible for:

- a) submitting a completed nomination form;
- b) securing two separate endorsements of the nomination, together with their supporting signatures;
- c) contacting the nominee (before submitting) to confirm their willingness to stand.

The nomination process may be initiated independently by a nominator or by a person of the candidate's choice. Self-authored letters of nomination are not accepted.

Nominators should indicate clearly the award category under consideration, complete all fields in the nomination form, and ensure that they have understood and agreed to the terms and conditions of the nomination process. In order to keep the selection process fair, any additional documentation (references, resumes, etc.) will be disregarded by the adjudication committee.

<b>November 16, 2018</b>	BCCAT Transfer Awards Ceremony to be held in conjunction with the 2018 Joint Annual Meeting. **ADJUDICATION, SELECTION AND AWARD PROCESS**

Nominations are reviewed and adjudicated by a peer representative committee. Members of the Awards Committee are selected by BCCAT to represent those serving in a variety of roles to support transfer and articulation (e.g. senior administrators, faculty, transfer credit support staff, and advisors) and to reflect the diversity of the BC Transfer System.

The adjudication committee forwards recommendations to the Council, and the Council makes the final decisions regarding successful candidates. The Awards Committee reserves the right to consider nominees under different award categories, where seen to be appropriate. Award winners will be notified shortly after Council deliberations on October 5, 2018. The Awards Ceremony will be held on **Friday, November 16, 2018** in conjunction with the 2018 Joint Annual Meeting.
