- VI. Introductions & roundtable to briefly summarize new initiatives at institutions: one rep per institution, 3 mins each (10:05-11:30)
  - 1) Institution Reports are posted on Moodle site for review.
  - 2) Overall Trends:

#### **Demographics:**

- Increase in students from India to the point that largest population of EAL students in many institutions are now from India. (UFV, Langara, VCC, Coquitlam, Fairleigh Dickinson, Ascenda, Cap U, Selkirk, College of the Rockies, Columbia)
  - Many of these students experience challenges with university readiness in addition to language
  - o Some of these students the goal is immigration and not study
  - o Challenges with IELTS scores reflecting English ability (concerns about corruption)
  - Anna remarked that 2018-2019 was the first year where the number of Indian students was the largest province-wide

#### **Enrollment:**

- Many institutions have experienced a drop in numbers of international students (UFV, VIU, Douglas, Camosun, Cap U, Langara, KPU)
  - o Impact of raising IELTS scores to 6.5 for entry to university in some institutions (VIU)
  - Restrictions on numbers of international students at some institutions (Douglas, Alexander, KPU)
  - Impact of Student Direct Stream (SDS) which requires an IELTS 6.0 meaning fewer students coming to EAP programs from India – most are direct entry
  - "Vietnam wave is over"
  - o Some institutions required to lay off staff due to decreasing enrollment (KPU)
  - Proposal to discontinue Faculty at KPU and move departments to other Faculties
  - Students bypassing ESL programs at BCIT register for Part-Time studies, no proof required for language proficiency – under review

#### • Responses:

- Several institutions have had an increase in domestic students, or are pushing to increase domestic enrollment (Douglas, Camosun, Cap U
- Increase in short-term programs or "add-on" programs (eg. business,) UVIC
- New Partnerships with universities abroad (Cap U, SFU)

#### Leadership:

 Leadership changes in majority of schools – new Deans, Presidents, VP Academic or reported current search for new leadership (VIU, Langara, Douglas College, Selkirk, College of the Rockies, Alexander, UCW, KPU, TRU, Columbia, BCIT, CNC)

- New support systems for students and staff
  - Langara new mental health framework and Internationalization strategy;
  - Cap U Internationalization committee;
  - Selkirk Community meetings with local community and international students; partnership with BC Transit between campuses / cities (Nelson, Trail and Castlegar)

- Dealing with the stigma of "ESL" "EAP" new subject codes proposed (Cap U, Alexander)

VII. Provincial ESL Update: Barb Binczyk, Adult Education Unit, Programs Branch, Ministry of Advanced Education, Skills and Training (12:05-12:30)

- 1) Senior Policy advisor for AEU Involved with Adult Basic Education, Adult Special Education and EAL
- 2) Adult Upgrading Grant Eligibility thresholds increased to \$30,600 for funding
- 3) Maximum amount allowable reduced to \$30,000; more demand on community; Ministry is currently reviewing 101 proposals
- 4) Tuition Free Policy for EAL December 2017 Since then Institutions Invoicing Ministry \$24 million budget should be stable over new couple of years. Can possibly request more from Treasury.
- 5) Model for 19-20 tuition reimbursements upfront amount based on forecasted FTEs (based on ABE and ELL 19-20 forecast); No increase in base funding
- 6) After reductions were implemented in 14-15; ELL fell by 56%, ABE by 27%; 35% reduction overall;
- 7) ABE numbers have remained largely static
- 8) Many students still don't realize EAL is tuition free; relying on individual institutions to promote; ministry does not promote
- 9) Why are ELL students still coming? Response hitting the pavement; Facebook campaign; marketing has helped numbers
- 10) How much capacity do institutions have to keep increasing when current government funding only covers cost of tuition, not overhead costs?
- 11) Year-End Funding
  - a. Surplus needs to be used to directly benefit students; for Adult Special Education aimed at reducing waitlists; re-new / relaunch programs that had been cut
  - b. Funding for Disabilities projects universal design; nurse practitioner

- XII.EAP action plan for 2019 (key items, research proposal potentials (TIFs), call for volunteers, etc.) (9:00 9:30) and Report from System Liaison Person and Deans and Directors: Tanis Sawkins
  - 1) SLP Role: Administrator from BC Transfer System committee, mentor co-chairs, attend JAM, institutional contact person attends JAM, acts as liaison between ESL articulation committee and other articulation committees in developmental education including ESL, ABE, ASE, advocates on behalf of ESL committee.
  - 2) Initiative in ABE in changing their curriculum to align with K-12 school system which has dominated development education meetings in the last 3 years.
  - 3) Recommended **ACTION:** visiting BCCAT website committee companion guide.
  - 4) Committee request to bring forward ability to hold committee meetings outside Lower Mainland.
    - a. **Response:** Original decision to keep BCCAT meetings to the Lower Mainland due to ABE having a disproportionate cost in expenses because of a larger number of committees
    - b. Tanis suggested developing a rationale for need to travel to other communities for BCCAT Meetings
    - c. Ideas: Missing representation and voice from Northern Communities; Expensive for schools outside of lower mainland board to travel every year, can often send only one person or sometimes cannot attend
  - 5) Concern about decline in numbers of domestic students
  - 6) Concern from the committee on why an articulated course not recognized at a receiving institution, while a LINC report card is for the purposes of language requirement for the federal government.

#### Last year's action items:

- 1.) Visibility of the EAP Articulation Guide on the BCCAT website
- 2.) Usability of EAP Articulation Guide
  - a. Missing information about which courses are credit bearing difficult for advisors
  - b. Need to change guide to a format where registrars and those making transfer decisions can understand and make decisions. Need equivalency information. Suggested interactive equivalency tool.

#### Discussion:

- 1. Concern that some Institutions not accepting EAP 4 even when articulated.
  - a. **Response:** Institutions have the autonomy to make admissions decisions separate from articulation. Registration sometimes missing knowledge about articulation. Articulation Guide in its current form is cumbersome and hard to use.
- 2. **ACTION:** Suggestion for committee members to review prerequisites for one's own institutions does it say EAP 4 or the school's own EAP 4 course.
- 3. ACTION: Committee members are to connect with institutional contact person

  - Question: Does Douglas College accept "mastery" at 70% of outcomes at ACE 3 (IELTS 6.0) to be accepted into Douglas College (IELTS 6.5) for entry?

- of where courses fit on grid when changes are met. Try to avoid "omnibus" lists of EAP outcomes from the Guide tied to one course outcome / objective

   Labelling is need for Douglas College in grid to ensure that it's understood that the integration covers reading and listening
